Exhibit Booth Contract



The undersigned lessee agrees to rent _____ booth(s) from American Feed Industry Association (AFIA) during the 2010 Liquid Feed Symposium at the Henry B. Gonzalez Convention Center in San Antonio, Texas.

The cost of each 8' x 10' booth includes 8' high draperies at the back of each booth, 3' high dividers at the sides, an identification sign, one draped table and two chairs. One fully paid registration for all symposium functions is included for \$640 AFIA member rate and \$1,085 for non AFIA members. A double booth cost is \$1,220 for members and \$1,990 for non-members and includes two fully paid registrations. Additional registrations are available to exhibitors at a rate of \$354 for members and \$708 for non-members.

The exhibitor shall be fully responsible to pay for any and all damages to property owned by the Henry B. Gonzalez Convention Center, its owners, managers, officers or directors, agents, employees, subsidiaries and affiliates, from any damages or charges resulting from the exhibitors use of the property. The exhibitor's liability shall include all losses, costs, damages, or expenses arising from or out of, or by reason of any accident or bodily injury or other occurrences to any person or persons, including the exhibitor, its agents, employees, and business invitees which arise from or out of the exhibitor's occupancy and use of the exhibit premises or any part thereof. The exhibitor will also order and pay for any additional equipment or services it may need from the exhibit service company contracting with AFIA. This lease is subject to all rules and regulations of American Feed Industry Association with respect to the AFIA Liquid Feed Symposium and the Henry B. Gonzalez Convention Center, San Antonio, TX.

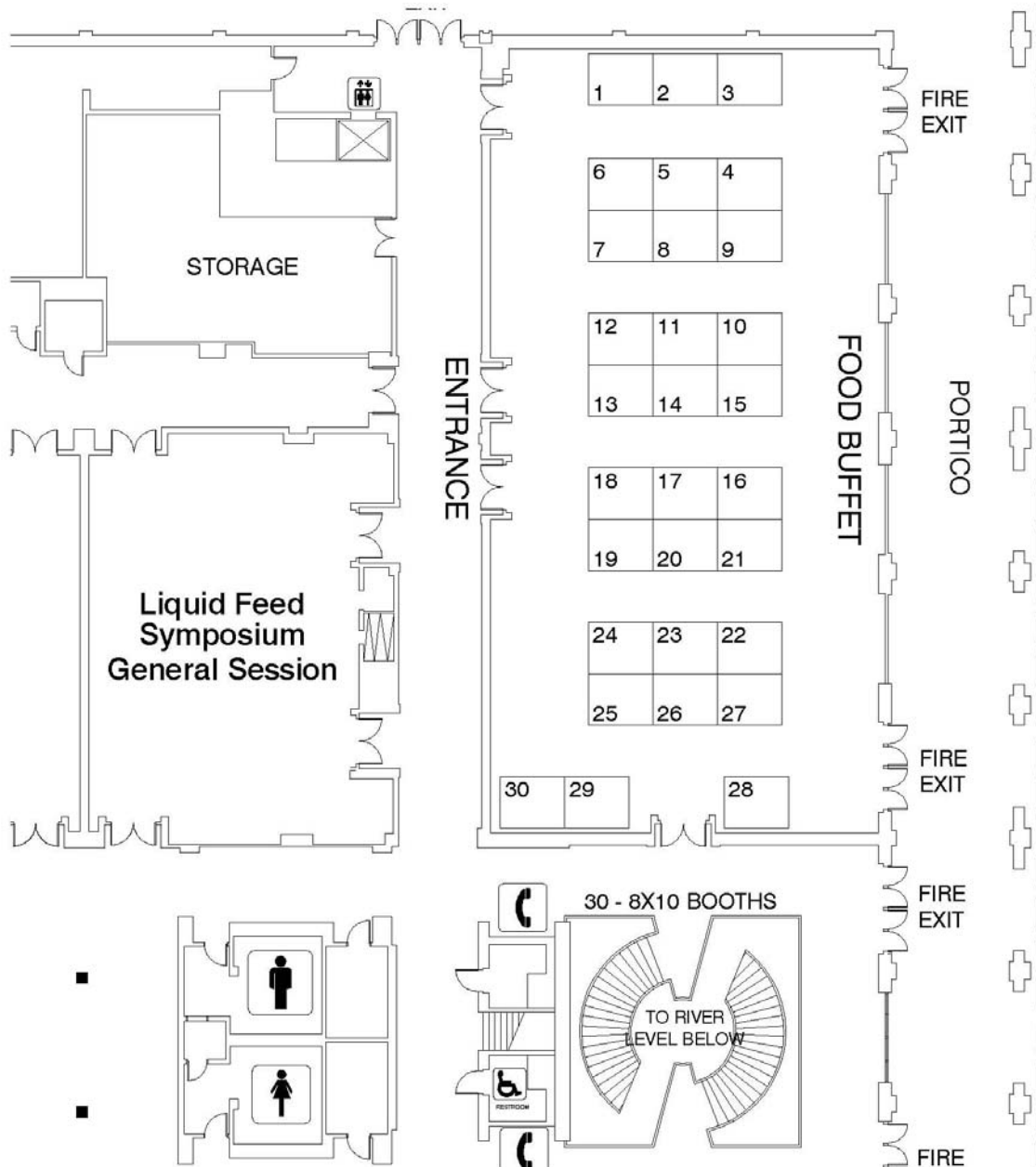
