



## **2021 Buyers to PISC– Program Details**

The American Feed Industry Association is offering a “Buyers to PISC” program for this year only. AFIA is targeting member-company professionals in buying roles who normally would not have the opportunity to attend this annual event. Five individuals will receive one (1) complimentary registration and travel stipend to the 2021 PISC in Orlando, August 17-19.

### **Goal:**

To invest in and engage buying professionals who work for member companies and facilitate networking opportunities at PISC.

### **Applicant Qualifications:**

- Must work for an AFIA member company actively involved in the production of animal feed or feed ingredients
- Must work in a buying role at an AFIA member company
- Must be a first-time attendee to PISC
- Have support of senior staff at their company
- Executives may nominate no more than two (2) individuals from the respective organization
- **Nomination must be received by July 10, 2021 with a signature from a member of your management team (see attached form)**
- Winners will be notified by July 15, 2021

### **Selected individuals will receive the following:**

- Air travel (up to \$500) \*
- Two (2) nights lodging at conference hotel \*
- Complimentary registration to PISC \*
- Name recognition in program proceedings

### **\*Expenses:**

Selected individuals will be responsible for booking their own travel arrangements to and from Orlando. In addition to the complimentary conference registration, AFIA will pay for the following travel expenses for the winner: An economy class, round-trip plane ticket, not to exceed \$500 and two (2) nights lodging (room and tax only) at the conference hotel. AFIA will not cover ground transportation, meals or additional travel expenses. Selected participants are responsible for paying all other travel expenses not included in this document, as well as your own incidentals. AFIA will not cover expenses incurred due to



a change or alteration of travel plans once travel arrangements are made; airline baggage fees; early check-in fees; or any type of upgrade. The golf tournament, sporting clays outing and any additional fee based education program are excluded from the complimentary registration. Selected applicants may send expenses, with copies of receipts, to Veronica Rovelli at [vrovelli@afia.org](mailto:vrovelli@afia.org) for reimbursement. Expenses must be received within 30 days after the conference in order to be considered for reimbursement.
